Jan Slaby is Professor in Philosophy of Mind and Philosophy of Emotion at Freie Universität Berlin, Germany.

My work spans the area between the philosophy of mind, social philosophy and philosophy of human and mind sciences. I work on aspects of an integrative account of the social constitution of mental capacities and liabilities by combining enactivism, extended mind and embodied mind approaches with approaches from social philosophy, critical theory and phenomenology. Affect and emotion are crucial themes of interest. Affect (dynamic, relational, pre-individual) and emotion (complex, agential, discursively formed, in constant evolution) present linchpins of mindedness, as they relate individuals to their surroundings while forming the pinnacle of subjectivity and selfhood. In this key lies my interest in the affective dynamics of social interaction and toward a 'political philosophy of mind'. I am also interested in the nature and methodological role of concepts in both the humanities and natural science research, and I have developed a critical perspective on the explanatory range and methodological potential of neuroscience. I'm currently also drawn to themes of political ecology, society-nature relations and the socio-ecological crisis both in its present form and with regard to its historical root causes.

With Suparna Choudhury (McGill University), I was co-initiator of the *Critical Neuroscience network* that has developed a critical contextualization of the human neurosciences, responding to the claim of an alleged 'neuro-revolution' in the human sciences, the humanities and the academy at large. With Christian von Scheve and other colleagues, I have co-edited two volumes on the *Key Concepts in Affective Societies*.
